



**GOVERNING COUNCIL OF THE CAT FANCY**  
**IN ADVANCE OF THE POSTAL ELECTIONS OF 2020**  
**CLUB DISPENSATION**



Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the Directors of the Company proposed in the list of Byelaw amendments following the cancellation of the June 2020 Electoral Meeting, a resolution to make provision for clubs in need of the dispensation that may be granted at Council by delegates in accordance with the note to Byelaw 3.

These are clubs whose membership numbers have fallen below those required for automatic representation at Council (Breed & Specialist clubs 50, 100 for All Breed Clubs), but who wish to retain a delegate.

They are to be listed on the GCCF website (as below) from 1 September and eligible delegates\* may make an objection if they so wish. If, by 28 September, objections are recorded from more than 50% of eligible delegates\*, the delegates from the clubs listed will be withdrawn as nominees (if so proposed) for Chair, Vice Chair, and a place on the GCCF Board or Finance Committee (although not as applicants for IC or the DC reserve), and will not participate further in the electoral process.

**Please note:**

1. Any objection is to **ALL** of those on the list, as is the case at Council. There are no rules or established procedures for singling out individual clubs.
2. If you are the delegate of club requiring dispensation you may stand (be nominated) as a GCCF Officer or Board/committee member, but may not make nominations. You are not classed as an eligible delegate until other Council delegates have confirmed your position on 28 September by a majority not registering any objection.
