	11.2 Words bearing a close resemblance to an existing prefix (words within one letter or sounding the same are considered to bear a 'close resemblance') and existing prefixes should not be followed by 'CAT/S' or any alternative spelling of 'CAT/S'.		
	Rationale: It is easy for an existing prefix to be confused with one with 'cats' added, particularly via an internet search (eg Owletts cats and Owlettscats). This may come about entirely accidentally, but it's thought that the less than scrupulous could want to take advantage of a connection with past and present well known prefixes, as it is occurring in applications more frequently.
