 THIS RULE INCLUDES ALL OTHER CATS AND KITTENS FROM THE SAME CATTERY/HOME

**Rule 3: In order to exhibit in any show held under GCCF licence** the registered owner(s) must complete the official entry form for the show and abide by and subscribe to the following declaration

**3a 1/ We am/are the registered owner(s) of the cats and/or kittens** named on this form and I/we agree to be bound by and submit to the constitution and Rules of the Governing Council of the Cat Fancy presently in force and to any additional rules formulated specifically for the Show, provided only that the latter do not conflict with the former, And/Or I/we shall have applied for registration/transfer at least 21 days before the Show.

**3b No cat owned by me/us or living at the, same address will be** exhibited at or entered for any show or Public Exhibition within 13 days prior to OR following the date of this Show. **NB the owner of a cat is the person so named in the GCCF register (Section 4, Rule 1b).**

**3c (1) In the event of ear mite infection being diagnosed in my/our** cattery/household by a Veterinary Surgeon, no cat owned by me/us or living at the same address will attend any Show/exhibition until such as all cats owned by me/us and or living at the same address have been examine' by a Veterinary Surgeon and pronounced free from ear mite infestation.

**3c (2) In the event of ringworm infection being diagnosed in my/our** cattery/household a Veterinary Surgeon, I/we will inform the GCCF Office and neither I/we nor any cat owned by me/us and /or living at the same address will attend any Show/Exhibition until a Clearance Certificate, as required by the GCCF has been obtained

**3c (3) In the event of any other infectious disease with the exception of Feline Leukaemia Virus.** or Feline Immunodeficiency Virus being diagnosed by a Veterinary surgeon in my/our cattery/household, no cat owned by me/us or living at the same address will attend any Show/Exhibition until at least one month after all cats owned by me/us and/or living at the same address have been examined by a Veterinary Surgeon and pronounced free from any evidence of the disease in question

**3c (4) Cats showing positive reaction to the Feline Leukaemia Virus** blood test or the Feline immunodeficiency virus blood test must not be shown.

NB. Council strongly recommends that all cats should be regularly tested. Vaccination against Feline Leukaemia is also available.

**3d I agree to abide by any decision regarding rejection made by** the examining Veterinary Surgeon.

**3e To the best of my/our knowledge, the cats entered for this Show** has/have not been subjected to any surgery to correct any defect listed in the GCCF Standard of Points

Write distinctly and note that the columns must be filled in, in terms identical with the registration of the cat at the GCCF  
 All exhibits must have a current IF certificate (homeopathic Vaccination is NOT acceptable) at least 7 days before the Show. It may be required by the Vets.  
 Please forward a stamped addressed Post Card if Acknowledgement of entry is desired and please ensure that you are a fully paid up member of the Club Classes you enter  
 This entry is to be processed by Computer, Print clearly to avoid errors  
 Please note a Standard of Points MUST be sent with all assessment exhibits.  
 Please note that in addition to the classes you have entered. your cat may also be handled for the purposes of assessing candidates in the GCCF judge appointment scheme
